



NORC AmeriSpeak Omnibus Survey: Public Believes Nicotine-Based Smoking and Vaping Products Are More Harmful Than Those Containing THC

Interview Dates: September 19-24, 2019 and February 14-18, 2019

The September results are based on a nationally representative sample of 1,052 English-speaking adults age 18 and over, conducted using an Omnibus survey of the AmeriSpeak® Panel, the probability-based panel of NORC at the University of Chicago. Of the 1,052 respondents, 93 completed the survey by phone and 959 via the web. Margin of error +/- 4.24 percent. The February results are based on a nationally representative sample of 1,004 English-speaking adults age 18 and over, conducted using an Omnibus survey of the AmeriSpeak® Panel, the probability-based panel of NORC at the University of Chicago. Of the 1,004 respondents, 101 completed the survey by phone and 903 via the web. Margin of error +/- 4.12 percent.

The polls and analysis was self-funded.

AmeriSpeak® is designed to be representative of the U.S. household population. During the initial recruitment phase of the panel, randomly selected U.S. households were sampled with a known, non-zero probability of selection from the NORC National Sample Frame and then contacted by U.S. mail, email, telephone, and field interviewers (face-to-face). The panel provides sample coverage of approximately 97 percent of the U.S. household population. Those excluded from the sample include people with P.O. Box only addresses, some addresses not listed in the USPS Delivery Sequence File, and some newly constructed dwellings.

NOTE: All results show percentages among respondents, unless otherwise labeled.
